Dear Individual User:

Enclosed are your Annual Water and Use Report forms for calendar year 2011. The summary page is printed on the reverse side of this letter. This report is for Individual Users who receive water from a service area right holder or irrigation district. The Department has preprinted certain information from our records onto these forms. If any of the preprinted information is incorrect, please make the necessary changes. Please note that a separate annual report form must be filed for each facility designated as an individual user.

Persons who did not receive water during 2011 are required to return the form with zeros in the appropriate blanks.

Reports must be received by the Department or postmarked no later than March 31, 2012. The penalty for filing late is \$25.00 per month or part of a month that the report is late up to \$150.00. In addition, after six months, the Department may take further enforcement action for failure to file an Annual Report, including seeking civil penalties in an amount not less than \$250.00.

We have tried to provide you with the proper forms according to information in our files. Failure to receive the proper forms does not relieve a person of the responsibility of keeping the required records or filing the required reports. You may wish to copy this report for your records.

INSTRUCTIONS

PART 1 - TURF-RELATED WATER USE

Indicate, next to the types of water, the amount of water received from another entity used for landscape related watering in calendar year 2011. Any water use for a purpose **other than landscape watering or filling lakes** (such as clubhouse use, equipment washing or swimming pool) that has been separately metered may be subtracted from the total use. The associated meter readings must be included along with a brief explain of the purpose of that use.

PART 2 - LANDSCAPE INFORMATION

- 1) Indicate if there has been a change in your landscape or water surface acreage.
- 2) Indicate the total acres or percent of turf acreage that has been overseeded.

6-310 Monitoring and Reporting Requirements for Turf-Related Facilities:

An industrial user who uses water at a turf-related facility that commences watering to any new turf acres, low water use landscaped area or water surface acres after January 1, 2011 shall submit to the director documentation of the new acres no later than 90 days after commencement of providing water to the new acres or receiving notice of these conservation requirements, whichever is later. The scale of the submitted documents, extent of turf acres, water surface acres, and low water use landscaped area must clearly be shown as well as verifiable.
